

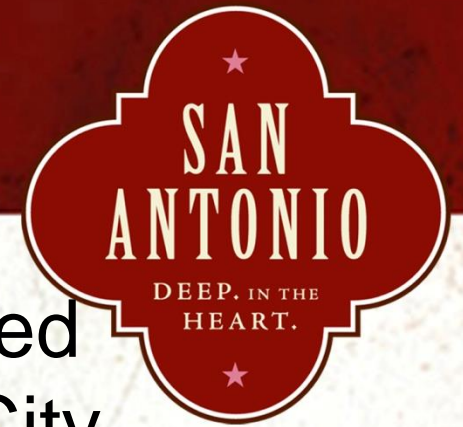

# History



- On Wednesday, April 11, 2018, I received Three Petitions seeking to amend the City Charter as follows:

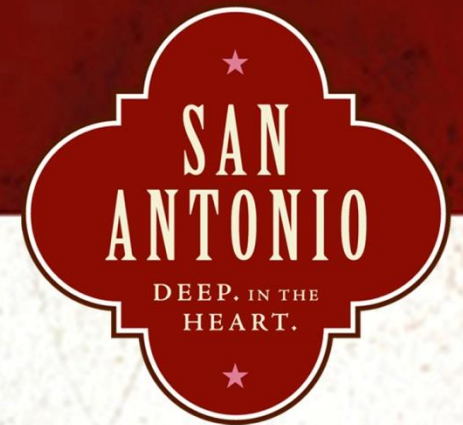
Petition 1: “Petition for a City of San Antonio Charter Amendment to Set a Limit on the Appointment, Term of Appointment, and Salary of a City Manager.”

Petition 2: “Petition for a City of San Antonio Charter Amendment to Facilitate Voter Use of the Referendum Process.”

Petition 3: “Petition for a City of San Antonio Charter Amendment to Require Arbitration, in Lieu of Litigation, in the Event of Impasse in Collective Bargaining.”



# Verification Process



- The Office of the City Clerk utilized the Bexar County Elections Office Votec Elections Management And Compliance System (VEMACS) loaned to us at the Bexar County Elections Office.
- VEMACS was programmed in accordance with provisions outlined in Chapter 277 of the Texas Election Code. VEMACS allows users to search and verify by Voter Identification Number, Name, Address, or Date of Birth as well as providing for signature verification.

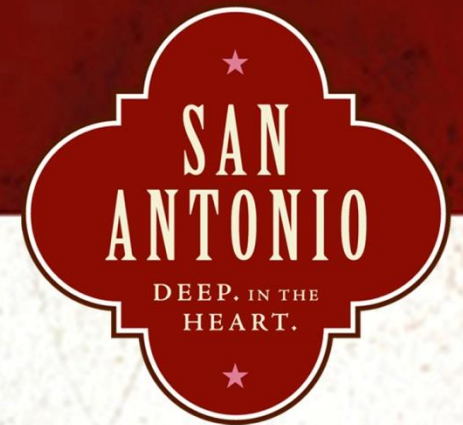
